Call for submissions

Submissions are now being accepted for ASMPVCV's first juried exhibition. ASMPVCV 2008-2009 Juried Exhibition is an opportunity for ASMPVCV members to showcase their personnel fine art works in a traveling exhibition. The goals of this exhibition are to raise money for the chapter, raise the profile of ASMP as an organization in our region and to promote and sell the work of ASMP photographers to our clients and the arts community. Subject matter for the exhibition is open ended as represented by traditional and digital photography.

The jurors for the exhibition are: National Geographic and Magnum photographer David Alan Harvey; Virginia Museum of Fine Arts, Paul Mellon Collection Educator, Jeffery W. Allison; and award-winning creative director for BCF Advertising, Keith Ireland.

Application Process

ASMPVCV photographers should submit a completed application, 3 to 5 work prints or finished prints, and a CD of jpeg files saved at 12 quality of the 3 to 5 submitted photographs. **NOTE:** Jpeg files should be in SRGB color profile with a size of 1400 pixels for horizontal images and 1050 pixels for vertical images.

The photographic image area may be any size, not to exceed 14 x 18 inches. Prints should be submitted with at least a 1-inch unprinted white border on all sides. All accepted prints will be framed 20 x 24 inches. Final prints must be of exhibition quality. There is a \$10 per entry fee for each print submitted. Entry fees are payable by check to ASMPVCV and are due upon submission of work prints.

Submitted prints should be delivered to Crittenden Studio, 201 West 7th Street, Richmond, Va., no later than 5 p.m. on Dec. 15. Accepted submissions will be notified by Jan. 5, 2009. Photographers will be expected to pay the cost of framing for each accepted photograph.

All work will be framed by a professional framer and adhere to museum quality standards. The cost of framing is \$113.87 per framed image. Framing fees are payable by check to ASMPVCV and are due upon submission of final selected prints. Accepted work must appear as the submitted images and specifications originally stated in the application.

Exhibition and Print Sales

Exhibition opening will be held at the Crittenden Studio at 7 p.m. on Friday, March 13, 2009 and will run for two months. Following the opening exhibition, the show will travel to additional venues and exhibition fees, if any, will be used as a continuing fundraiser for ASMPVCV. All inquiries regarding print sales will be directed to the photographer and photographer will receive all proceeds from print sales, less gallery commission, if any.

Rights Granted to ASMPVCV

Photographer retains copyright in work and grants to ASMPVCV the right to display work accepted for the show in a traveling exhibition, the right to display accepted images on www.asmpcv.com, in slide shows during ASMPVCV programs and meetings and in media kits and presentations promoting the exhibition and /or ASMPVCV.
